

**RESOLUTION NO. 18-5432**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA PUENTE, CALIFORNIA, RESCINDING RESOLUTION NO. 17-5357, AND AMENDING THE COMPREHENSIVE PERSONNEL SYSTEM AND ESTABLISHING THE NUMBER OF AUTHORIZED PART-TIME POSITIONS AND HOURLY RATES FOR CITY EMPLOYEES**

**WHEREAS**, the City Council wishes to establish the number of authorized part-time positions and hourly rates for City employees for the 2018-2019 fiscal year, effective July 1, 2018.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LA PUENTE HEREBY FINDS, DETERMINES AND RESOLVES AS FOLLOWS:**

SECTION 1. Effective July 1, 2018, Resolution 17-5357 is hereby rescinded.

SECTION 2. The hourly rates and position titles of Classified Part-Time, non-exempt authorized positions are as follows:



Community Services Specialist	10	13.40 – 16.29
Parking Control Officer	2	13.40 – 16.29
Office Assistant	1	16.29 – 19.80
Maintenance Assistant	5	17.10 – 20.79
Office Specialist	1	18.86 – 22.92
Maintenance Worker	1	20.79 – 25.27
Community Services Officer	2	21.83 – 26.53
Code Enforcement Officer	8	22.92 – 27.86

SECTION 3. The provisions of this Resolution are severable and if any provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, sections, words or parts thereof of the Resolution or their applicability to other persons or circumstances.


SECTION 4. That the City Clerk shall certify to the adoption of this Resolution and that the same shall be in full force and effect.
